They will ask the Link Group for feedback and advice.



How the Groups report back to the Partnership Board.

The work groups will report to the partnership board so that we can see how the plan is going.

 The work groups will have a list of things to do. These are called actions. Emma from Speak
Out will make a form
for the groups to fill in.

The Link Group will answer questions that work groups have.







- Twice a year each group will come to the Partnership Board to let us know what they have been doing.
- Before the meeting they will fill in a form saying what work they have done and what work they still need to do.
- They will send this form to the Link Group. This means the Link group can ask questions and think of feedback before the meeting.


The groups will use easy words when they speak at the Partnership Board.
